SWG FUNCTIONALITY

In 2021, no changes were noted in respect to regulation of work by SWG Regional and Local Development. This sector group operates according to the 2 x meetings: 04.06.2021 06.07.2021

rules of procedure adopted in 2019. Ministry of Local Self-Government's **website** hosts information on IPA cross-border and territorial cooperation, but there are no information related to performance of this sector group.

CIVIL SOCIETY PARTICIPATION

Seven (7) civil society representatives participate in this SWG (15% from the total number of SWG members), with the status of members. Invitations for plenary sessions held in 2021 were timely distributed to civil society representatives and were accompanied by all documents needed. However, conditions need to be created for civil society representatives in this sector group to also participate in processes for identification, formulation and priority-setting of developmental goals, measures and projects for implementation of national policies and strategies in this sector.

CSO CAPACITY

The rules of procedure need to amended in order to define the model for selection of civil society representatives and their role and mandate in work performed by this sector group. The current approach does not fully utilize capacity of civil society organizations.

EFFECTS FROM SWG WORK

SWG Regional and Local Development held two plenary sessions in the course of 2021. These meetings mainly concerned presentation of previously developed and adopted legal solutions, programs and projects.

This process is covered under the Program for Sustainable Local Development and Decentralization 2021–2026, adopted on 6 April 2021. Priorities under this program are grouped into four components, as follows:

- Normative and local self-government financing framework

- Enhanced resilience of local governments and sustainable development
